#### What data do we collect?

Cirrus Instruction Europe DTO collects the following data:

- Personal identification information (Name, email address, phone number, etc.)
- Invoicing details
- Flight Crew Licence and Medical copies
- Ratings and relevant training documents
- Logbook details, as far as relevant for your training/exams at our DTO

## How do we collect your data?

Cirrus Instruction Europe DTO collects data and process data when you:

- Have contacted us and intends to follow training
- Agreed to follow one of the training courses we provide.
- Completed and returned the Client Registration Form.
- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.

Cirrus Instruction Europe DTO may also receive your data indirectly from the following sources:

- Cirrus Sales & Service BV, Groningen

## How will we use your data?

Cirrus Instruction Europe DTO collects your data so that we can:

- Provide feedback on questions you may have
- Make training proposal(s)
- Set up and conduct training as agreed
- Check and monitor logbook, licence, medical, endorsement and training progress (syllabus) to ensure all conditions are met prior to a skill test or flight review.
- Email you with news and services we think you might like.

### How do we store your data?

Cirrus Instruction Europe DTO securely stores your data at secured NAS at the Wings Hotel Rotterdam as well as via a Dropbox account.

Cirrus Instruction Europe DTO will keep your data [see 'what data do we collect'] for 3 years from the date we provided the last training course in accordance with that programme<sup>1</sup>. Once this time period has expired, we will delete your data by selecting data that is older then three years old and deleting it.

### What are your data protection rights?

Cirrus Instruction Europe DTO would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

**The right to access** – You have the right to request Our Company for copies of your personal data.

The right to rectification – You have the right to request that Our Company correct any information you believe is inaccurate. You also have the right to request Our Company to complete the information you believe is incomplete.

**The right to erasure** – You have the right to request that Our Company erase your personal data, under certain conditions.

**The right to restrict processing** – You have the right to request that Our Company restrict the processing of your personal data, under certain conditions.

**The right to object to processing** – You have the right to object to Our Company's processing of your personal data, under certain conditions.

**The right to data portability** – You have the right to request that Our Company transfer the data that we have collected to another organization, or directly to you, under certain conditions.
